The undersigned is directed to refer to your online application no. IA/WB/THE/25256/2014 dated 21.2.2018 regarding change in name of the company.

- 2. It has been noted that Environmental Clearance issued by Govt. of West Bengal vide letter No. EN/1125/T-II/001/2009 dated 12.4.2010. An amendment in EC for change in configuration from 3x135 MW to 3x150 MW, extension of validity of EC for two years i.e. till 12.04.2017 and amendment in EC for change in coal source to 100% imported coal and 30% domestic coal from e-auction incase of shortfall of imported coal were accorded by this Ministry on 14.10.2014, 13.08.2015 and 17.10.2016 respectively. Further, the validity of EC has been extended till 30.10.2019 vide Ministry's letter even dated 10.10.2017.
